Sub: Limited Departmental Competitive Examination for Telecom Technical Assistant (under 40% quota) for the recruitment Year 2008.

Sir,

I am directed to refer to AGM(Pers. III), BSNL C.O. letter No. 250-27/2008-Pers. II dated 30.6.2009 conveying the approval of the competent authority to hold the Limited Departmental Competitive Examination for Telecom Technical Assistants (TTAs) under 40% quota for the Recruitment Year 2008. As already conveyed the examination shall be held as per the Recruitment Rules of TTA circulated vide Pers. III Branch letter No. 250-41/2001-Pers. III dated 27.7.2001 and amendments issued in this regard. Further, the Syllabus of the examination will be as circulated vide Pers. III Branch, BSNL C.O. letter No. 250-76/2001-Pers. III dated 17.10.2001 and the scheme will be as circulated vide letter No. 250-76/2001-Pers. III dated 4.12.2008.

2. Before notifying for the examination the Circles are requested to ensure that conditions with regard to unfilled vacancies stipulated in Pers. III Branch letter dated 30.6.2009 have been complied with. It should also be ensured that no court case with regard to previous examination of this cadre is pending and also the process of Supplementary examination has been completed. In the notice of the examination it should be clearly mentioned that the result of the examination shall abide by the out come of the SLP No. 24750-24752/2008 pending before the Hon'ble Supreme Court.

3. The Limited Departmental Competitive Examination for Telecom Technical Assistant (under 40% quota) for the recruitment Year 2008 the examination shall be conducted centrally by the concerned Circle in accordance with the rules of departmental examinations laid down in Appendix No. 37 of P&T Manual Vol. IV and instructions issued in this regard from time to time. The schedule of the examination shall be decided by the respective Heads of the Circle keeping in view the schedule of the examination conducted centrally by the Corporate Office, the provisions of ibid Rules of Departmental Examination and constraints of the Circle.

4. Like all other decentralized examinations, all the work relating to the examination such as nomination of examiners, evaluation of answers books by such examiners, preparation and declaration of result, etc. will be carried out by the respective Circles and the entire process of the examination should be completed within a maximum period of six months from issue of this letter.

5. In the event of any query relating to eligibility conditions, Circles should refer the same to AGM (Pers.-III), BSNL Corporate Office for clarification.

6. The progress of holding the examination may be communicated at important stages.
