Sub: - **Agitational programme by BSNLEU, Kerala circle union – Requesting kind intervention – req.**

We wish to bring the following to your kind notice, for favour of your necessary intervention.

The Kerala circle union of BSNLEU has started agitational programme for the settlement of issues related to the improvement of services, as well as staff grievances. Protest demonstrations were organised throughout the circle on 17.07.2018. The next programme is mass dharnas, to be conducted at all SSA Head Quarters on 06.08.2018.

The demands raised by our Kerala circle union is related to the removal of the deadlocks in provisioning FTTH connections, improving the services of landlines, broadband connections and mobile services in the circle. Non-settlement of staff grievances, such as medical claims and problems related to NEPP have also provoked the employees to start this struggle programme.

The Corporate Management must realise that, it's decision to retrench contract workers, as a measure to control expenditure, is having adverse impact in the maintenance of services. This has resulted in the deterioration of the quality of BSNL's services. Being an organisation which is seriously concerned about maintaining good quality services, naturally BSNLEU, Kerala circle, has taken up this issue also in it's agitational programme.

We earnestly urge upon you, to kindly issue necessary instruction to the officers concerned, so that the issues raised by our Kerala circle union are looked into with due seriousness, so as to avoid the next phase of agitation. A copy of the letter, given to the CMD BSNL, by the CHQ of BSNLEU, on the issue of gainfully reengaging the retrenched contract workers, is also enclosed for your ready reference. We once again request you to kindly look into the matter and to do the needful.
